- 4. Receive Modified Treasurer's Report/Accounts Payable:
- A. Approval to pay DTE Energy bill (\$878.29)
- B. Approval to pay Consumers Energy bill (\$4,370.70)

Motion made by Brian Hettinger; seconded by Steve Heiss to pay DTE and Consumers Energy bill. Motion passed.

- 5. Recreation Authority business for Board discussion and action:
- A. Discussion of increasing rental rates in 2020.

A motion to raise rates \$10.00 for Gym, Pool, and South Commons areas starting January 1, 2020 was made by Mike Oosterhouse; seconded by Brian Hettinger. Motion passed.

B. Rental Policies Update

Discussion took place about where in the building alcohol would be allowed. Alcohol will be allowed in the Community Room, South Commons and Gym if the Gym is not used for sporting events. Also discussed was the fact that 50% of future rentals will be non-refundable effective immediately. The remaining 50% will be refundable only if cancellation takes place 45 days or more of the event date. Motion to that effect was made by Mike Oosterhouse; seconded by Brian Hettinger. Motion passed.

C. Eviction of Powell Networks

After much discussion of Mr. Powell's lack of rent payment and a prior letter of pay or quit that was sent to him, a motion was made by Brian Hettinger; seconded by Steve Heiss to send one more notice to Mr. Powell stating that Mr. Powell has 10 days to pay or vacate the property. If, after 10 days neither action has taken place, FCRA will start the eviction process. Motion passed.

D. Family Fitness

Discussion of Family Fitness being behind in paying rent and utilities reimbursement. As of this meeting date, Family Fitness owes FCRA approximately \$15,000. FCRA will meet during the week of November 11 with the management of Family Fitness about getting payments up to date and Brian Hettinger will get an appraisal of Family Fitness' equipment.
